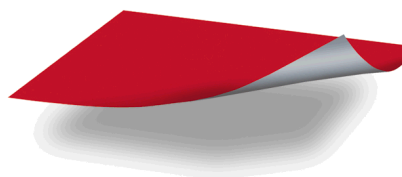
Conversion & printing
