This thick PVC product can be used for various applications where high rigidity is needed. A typical application is stick in the ground arrow tags in garden centers but also membership cards, loyalty cards or even garment hang tags.

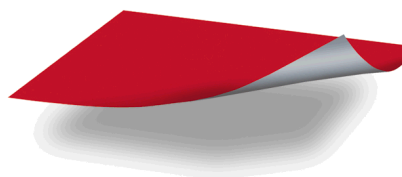
Conversion & printing

This PVC film can be printed with the following printing methods: screen and offset printing, flexographic printing, letterpress printing without pre-treatment. Due to its matt and relatively rough surface Thermal Transfer printing is possible, but it is recommended to set up the thermal transfer printer to low printing speeds.
