Shelf life

Unless specified otherwise in this document, one year when stored at 72°F at 50% RH. Processing must be carried out within 6 months after date of production. A longer shelf life has to be tested with the help of long term tests.

Storage

Storage at 15 – 35°C and 45-75% relative humidity is recommended for unfilled packaging.


