Adhesive Performance

The adhesive features excellent tack and adhesion on a wide variety of substrates, including apolar, slightly rough and curved substrates.

Particularly good performance at lower temperatures, e.g. labeling of chilled products.

Applications and use

This Direct Thermal product is designed for use in pre-packed food wet applications where excellent resistance to oil, water and plasticizer over an extended period is required. Typical end use applications include wet meat-packing, food cryovac, freeze-thaw (meat and fish) and wet cheese. Continuous exposure to an assortment of chemicals or continuous wet immersion will eventually cause image fading.

Automatic application: The robust film liner allows for consistent, snap free, application on high speed lines.

Conversion & printing

The product can be converted by all conventional roll conversion technologies including flexographic and UV letter press. However, due to the thermographic properties, exposure above 50°C may cause premature imaging or discoloration. It is advisable to test inks and varnishes before conversion.

We generally recommend not to pre-print the label area that needs to be thermally printed.

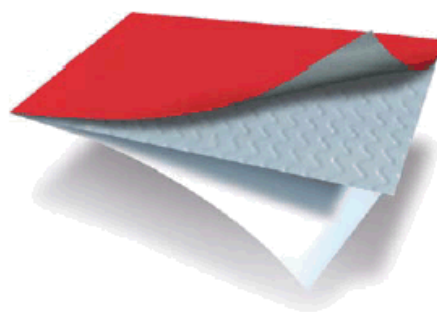
As the liner is transparent, the applicator must detect the print itself or registration marks must be provided on either face or liner.

Press stability is good with stable, consistent register during conversion. Flat bed performance is good while solid and magnetic rotary dies need additional care. (Die bearers must
