This PVC product can be used for various applications including loop tags around trees in garden centers but also many other identification tags with extended outdoor exposure.

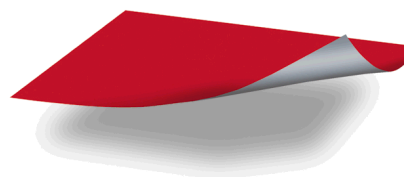
Conversion & printing

This PVC film can be printed with the following printing methods: screen and offset printing, flexographic printing, letterpress printing without pre-treatment. Due to its matt and relatively rough surface Thermal Transfer printing is possible, but it is recommended to set up the thermal transfer printer to low printing speeds.
