The product can be used in the flexible packaging industry as an economic wrapper for suger, seeds, sweets, pepper, salt, etc.

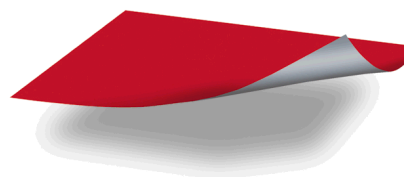
